Stamm made a motion to approve the agenda as presented. Evans seconded the motion. Vote: Aye unanimous Motion carried.

JULY 2, 2024, CITY COUNCIL MINUTES-

Gregory moved to approve the minutes of the July 2, 2024, City Council meeting as presented, seconded by Evans. Vote Aye: unanimous Motion Carried.

PRESENTATIONS/PROCLAMATIONS –

PARK AND RECREATION PROFESSIONALS' DAY PROCLAMATION

Mayor Truman read a proclamation declaring July 19, 2024, as Park and Recreation Professionals Day for the City of Valley Center. He offered his Thanks to Parks and Public Buildings Director Owings and his staff for all they do.

PUBLIC FORUM –

Michael Miller, 650 Scott St. addressed Council with comments about the 2025 budget. He felt that the possible cuts to the parks and public buildings should be shared by all departments. He also pointed out that due to house valuations increasing, property taxes have continued to go up.

APPOINTMENTS –

LEAGUE OF KANSAS MUNICIPALITES CONFERENCE DELEGATES

City Clerk Carrithers stated that the LKM conference is in Wichita this year. Valley Center can designate 2 voting delegates and 2 alternate delegates. Mayor Truman and Councilmember Colbert are planning on attending. Gregory also stated that she will attend the conference.

Gregory moved to approve – Ronald Colbert and James Truman -Voting Delegates and Brent Clark and Kristi Carrithers – Alternate Delegates for the League of Kansas Municipalities Conference. Seconded by Kerstetter. Vote yea: unanimous. Motion carried.

OLD BUSINESS –**A. ORDINANCE 1407-24: ALCOHOL COMMON CONSUPTION AREA**

City Administrator Clark presented for 2nd reading and final approval Ordinance 1407-24 establishing an alcohol common consumption area during the annual fall fest. Clark did state that the wording in Section 2-C was removed.

Stamm moved to approve Ordinance 1407-24 establishing an Alcohol Common consumption area during fall fest for 2nd reading. Motion seconded by Evans. Vote Yea: Unanimous. Motion carried.

B. ACCEPTANCE OF BID FOR GOFF DRAINAGE CONCRETE FLUME

Administrator Clark presented the bids for the concrete drainage flume. All bids were for a specific design. The lowest qualified bid of \$26,706.00 was received from Class Alpha Services. Kerstetter verified that work would be done this summer.

Kerstetter moved to accept bid from Class Alpha Services for concrete flume in amount not to exceed \$26,706.00. Motion seconded by Wilson. Vote Yea: Unanimous. Motion carried.

NEW BUSINESS-**A. 2023 FINANCIAL AUDIT REPORT:**

Sean Gordon with Gordon CPA presented the findings from the 2023 Financial audit. He stated that the city received the highest rating. He explained that pages 1-3 are the independent audit report. Page 4 is a finance summary, with pages 5-12 having notes on city finances. Details and breakout of funds can be found on pages 13-40. Gordon stated that they have no recommendation for the governing body.

Kerstetter moved to accept and file the audit report of the 2023 finances, seconded by Stamm. Vote yea: unanimous. Motion carried.

B. DISCUSSION OF GOLF CART ORDINANCE:

City Attorney Arbuckle and Public Safety Director Newman led discussion regarding potential changes to golf cart ordinance. The sample ordinance presented authorizes work-site utility vehicles, micro utility trucks and golf carts to be used within the city limits. ATVs would remain prohibited. It was proposed to issue a larger tag to be attached to the utility vehicle or golf cart and then issue stickers each year for renewal. This would allow police officers to quickly see the tags quickly. Discussion was also held regarding registration fees, penalties and tag transfers. Although no formal action was taken, the consensus was to keep the fees low, but cover the costs, increase fines with each infraction incurred by an individual and to allow a tag to be transferred to replacement vehicle for registered owner, but not new owner.

C. APPROVAL OF PURCHASE OF WWTP INFLUENT PUMP:

City Administrator Clark presented three bids for a replacement WWTP influent pump. This pump would be placed in storage as a replacement in the event of a future failure. This cost will be taken from the equipment line item within the sewer budget. The low bid was received from B & B Electric Motor Company.

Wilson moved to accept and award bid to B & B Electric Motor Company for a sewer pump in the amount of \$13,615.00. Motion seconded by Bass. Vote Aye: unanimous. Motion carried

D. KDOT SUPPLEMENTAL AGREEMENT #1:

City Administrator Clark presented supplemental agreement #1, with KDOT. The agreement reflects a change in the Letting Date for the Seneca Street Reconstruction Project. The date will be no later than six months after August 2025.

Anderson moved to approve Supplemental Agreement #1 with Kansas Department of Transportation for Seneca Street project and authorize Mayor or City Administrator to sign. Motion seconded by Bass. Vote Aye: unanimous. Motion carried

E. CIP PRESENTATION AND DISCUSSION

Finance Director Miller presented the Capital Improvement Plan for years 2024-2033. Miller highlighted the project changes made. A listing of changes can be found on page 3 of the CIP. Miller requested Council approve CIP through FY 2033.

Bass moved to adopt Capital Improvement Plan for FY 2024-2033. Seconded by Stamm. Vote Yea: unanimous. Motion carried.

Reported that staff has met with IMA regarding employee insurance and benefits for 2025. The safety committee also met with the workman’s comp safety auditor, and the city will again receive the “gold” star for safety practices.

CITY ADMINISTRATOR CLARK

Announced that Kyle Fiedler has accepted the Community Development Director position. He is currently the City Administrator for North Newton. His first day will be August 5th.

Dear Mr. Clark,

Please accept this letter on behalf of Ryan Nett, managing member, as our formal request for a waiver of the Subdivision Regulations for curb and gutter at Rio Bella Addition.

Our development group has a record of success in the development of larger, rural estate properties ranging from 2 to 5 acres in size. A successful development of this type utilizes a roadway section consisting of a 27-foot-wide asphalt driving surface with open ditches adjacent on each side. In addition, the roadway ditches are constructed with gentle fore and back slopes to allow easy mowing and maintenance (4:1 minimum fore slope, 5:1 minimum back slope). Driveways each have a culvert across the open ditch, and we require the use of a headwalls on each side to keep in line with the aesthetics of the addition. Given the larger lot sizes and reduced lot density residents tend to utilize bicycles to navigate the neighborhood, and sidewalks are not utilized or desired. Our goal is to create an estate type suburban neighborhood. This subdivision will be similar to a recently completed subdivision, Ceterra Addition, located near Seneca and 85th Street, just south of Fiddlers Creek.

On the next page we have included several photos from our recently completed Lakewood Hills Development that utilized this same type of roadway design. We anticipate the price range of our new homes between \$500,000 to \$1,000,000+.

We would also ask to have as an option the use of on-site advanced treatment systems (ATU's) to meet the sanitary disposal needs for each lot. We utilized ATU's on our Ceterra addition in Valley Center and Lakewood Hills Addition development in Park City, Kansas (see attached sales map) and found it to be very acceptable to the individual homeowners and utilized the installation and maintenance standards adopted by Sedgwick County MABCD.

We recognize this type of development varies in nature from typical single-family areas which typically have much more lot density and because of this proximity benefit from curb and gutter streets, sidewalks, and sanitary sewer collection systems. Our desire is to develop estate lots on this parcel as it is well suited to the rural estate development concept. We specifically are requesting the following waivers from the subdivision regulations:

1. A waiver from the use of curb and gutter roadways with underground storm water sewer, instead, using the open ditch, asphalt paved roadway described above.
2. A waiver from the requirement of placing a sidewalk through this development.
3. A waiver to allow the use of on-site alternative sanitary sewer systems in lieu of the extension of public sanitary sewer.







City Administrator Clark will present a Fund Agreement between the City of Valley Center, Valley Center Recreation Commission and Central Kansas Community Foundation. This fund agreement authorizes CKCF to establish a fund to receive and administer funds for the Valley Center Recreation and Aquatics Center Campaign Fund.

Special Project Fund Agreement for the Valley Center Recreation and Aquatics Center

THIS AGREEMENT is made as of the _____ day August 2024, between the **City of Valley Center and the Valley Center Recreation Commission**, Valley Center, Kansas ("Establishors"), and **Valley Center Community Foundation**, an affiliate of the **Central Kansas Community Foundation (CKCF)**, a §501(c)(3) charitable corporation organized under the nonprofit corporation laws of the State of Kansas, with its principal office located at 400 S Main, Suite 100, Newton, Kansas 67114 ("Foundation").

WHEREAS, CKCF is authorized to accept charitable contributions, subject to the terms set forth herein;

WHEREAS, Establishors and their representatives have designated their charitable intent to support a cause of significance to them as outlined in Sections III and IV; and

WHEREAS, CKCF has been established with a principal purpose to receive and administer funds as component funds for various charitable, scientific, or educational purposes and organizations in the community;

NOW, THEREFORE, the Parties agree as follows:

I. Establishment of the Fund. A fund shall be established on the books of the Foundation and shall be known as the **Valley Center Recreation and Aquatics Center Campaign Fund** ("Fund"). The Foundation acknowledges receipt of the property transferred at the establishment of this agreement and made a part hereof as the initial property of the Fund.

II. Property of the Fund. The Fund shall include the property received with the execution of this Agreement, such additional property as may from time to time be contributed from any other source for inclusion in the Fund and accepted by the Foundation, and all undistributed income from the foregoing property. The Fund shall be the exclusive property of CKCF, held by its corporate capacity, and shall not be deemed a trust fund held by it in a trustee capacity. CKCF shall have the ultimate authority and control over all property in the Fund, and the income derived from it, in accordance with the Articles of Incorporation and Bylaws of CKCF (as they may be amended from time to time), and the terms of this Agreement, applied in a manner not inconsistent with said Articles and Bylaws.

III. Designation of Purpose. The Fund shall be used for support of the charitable or educational purposes related to the service of the following qualified charitable organization: The City of Valley Center, Kansas. In particular, distributions from the Fund shall be made only for the Valley Center Recreation Commission for the benefit of the Valley Center Recreation and Aquatics Center.

Once the initial campaign for raising funds for the new recreation and aquatic center is achieved or at such time all parties agree, the Fund may be used for ongoing maintenance and operational support of the Valley Center Recreation and Aquatics Center.

IV. Administrative Provisions.

- a. **Distributions.** Distributions from the Fund shall be in accordance with the spending policy established by the Board of CKCF for its component funds. They shall be paid, upon Establishors' request, either directly to the Charity, or to such other §501(c)(3) or other qualifying charitable entity (e.g., school district, church, or arm of government) with oversight by the local Valley Center Community Foundation.
- b. **Administration.** CKCF hereby affirms that it will administer the Fund in accordance with the terms and subject to the conditions set forth by this agreement for an Expendable Designated Fund. The guidelines and procedures for such funds are described in CKCF's governing instruments, including its Articles of Incorporation, and Policies in effect, as amended from time to time. The Fund will be assessed an annual fee on the balance of the Fund and will share proportionately in any investment fees. CKCF shall retain and invest the assets of the Fund and may co-mingle those assets with other pooled investment funds of CKCF.

V. Reporting Responsibilities. The Foundation will provide online computer access to fund information to such persons as the Establishors may designate. Information such as fund balance, accrued investment earnings, gifts, fees, and disbursements will be made available online. Component funds are rebalanced each month upon receipt of investment reports, and monthly statements are prepared and available for distribution online.

VI. Public Acknowledgement. Establishors agree to allow the Fund to be listed in the publications of the CKCF and its affiliates.

VII. Variance Power.

- a. **Authority.** This Agreement is subject to CKCF's authority to vary the terms of the gift, with (if possible) prior notice to and input/recommendations from the PCF. As stated in Article V, Section 3 of CKCF's Bylaws, CKCF may exercise its variance power.
- b. **Notification.** CKCF shall promptly notify Establishors of any decision made to exercise its variance power. Notification of the exercise of the power shall be delivered in writing to the last known address of the Establishors within five (5) business days following the Board's decision. CKCF shall also notify the Establishors if it becomes aware of any other action instituted or proposed by any person to vary the purposes, uses, or method of administration of the Fund.
- c. **Cessation or Dissolution of CKCF.** If CKCF ceases to be a qualified charitable organization (as defined in Section VIII), or if CKCF proposes to dissolve, the asset of the Fund shall, after payment or making provision for payment of any liabilities properly chargeable to the Fund, be distributed to a qualified charitable community foundation designated by the Establishors and Valley Center Community Foundation.
- d. **Exercise of Variance Power.** Subject to the provisions of paragraphs VII. a. and b. above, the CKCF Board shall have the power to modify any restriction or condition on the

distribution of funds for any specified charitable purposes or to specified organizations if, in the sole judgment of the Board (without the approval of any trustee, custodian, or agent), such restriction or condition becomes, in effect, unnecessary, incapable of fulfillment, or inconsistent with the charitable needs of the community or area served. Establishors acknowledges the authority of the CKCF Board to alter distributions, but it requests that, to the maximum extent possible, the purposes stated in this Agreement be followed.

VIII. Definitions and Construction.

- a. **Definitions.** As used in this Agreement, the term “qualified charitable organization” means an organization described in §501(c)(3) of the Internal Revenue Code, which is other than a private foundation under §509(a) of the Internal Revenue Code. References herein to any provision of the Internal Revenue Code shall be deemed references to the U.S. Internal Revenue Code of 1986, as now in force or later amended, or the corresponding provision of any future United States Internal Revenue law.
- b. **Construction.** **It is intended that the Fund shall be a component fund of CKCF and that nothing in this agreement shall affect the status of CKCF as an entity that is a qualified charitable organization. This agreement shall be interpreted in a manner consistent with this intention and so as to confirm the requirements of the Internal Revenue Code and any regulations issued pursuant thereto applicable to the intended status of CKCF.** (Emphasis added.)

NEW BUSINESS**C. AGREEMENT WITH SEDGWICK COUNTY FOR HARVEST PLACE DRAINAGE IMPROVEMENTS:**

City Administrator Clark will present agreement with Sedgwick County for drainage improvements for Harvest Place -Phase 1. Proposed improvements are located southeast and southwest of the intersection of 93rd Street North and Meridian Avenue. Estimated construction costs are \$2,314.855.40 with 50/50 split between County and City.

- Harvest Place Phase 1 Drainage Improvements Agreement

AGREEMENT FOR HARVEST PLACE – PHASE 1 DRAINAGE IMPROVEMENTS

THIS AGREEMENT is made and entered into this _____ day of _____, 2024, by and between the Board of County Commissioners of Sedgwick County, Kansas, hereinafter referred to as “County” and the City of Valley Center, Kansas, hereinafter referred to as “City.”

WITNESSETH:

WHEREAS, County and City are authorized to enter into an agreement pursuant to K.S.A. 12-2908, as amended.

WHEREAS, the parties desire to make drainage improvements located southeast and southwest of the intersection of 93rd Street North and Meridian Avenue in the plans for the Harvest Place – Phase 1 Drainage Improvements, hereinafter referred to as the “Project”. The project includes stormwater detention facilities, storm sewers, and ditch construction to alleviate flooding concerns both onsite and offsite from Harvest Place.

WHEREAS, the southwest portion of the 93rd Street North and Meridian Avenue to be improved lies within the unincorporated areas of County; while the southeast portion of said intersection lies within the corporate limits of City.

WHEREAS, County desires City to construct said drainage improvements to correct long-standing drainage issues in the vicinity of the Project.

WHEREAS, City estimates the total estimated construction cost to be \$2,314,855.40 for the Project.

NOW THEREFORE, for and in consideration of the parties’ mutual promises and covenants, the parties agree as follows:

1. The purpose of this Agreement is to provide for the construction and financing of the Project.
2. County will pay for fifty percent (50%) of the actual costs of design, construction, and construction engineering of the Project. The total cost to the County shall not exceed \$1,157,427.70.
3. City agrees to pay for the actual costs of design, construction, and construction engineering of the Project. The total cost to City is estimated to be \$1,157,427.70. City shall be responsible for the balance of the project if costs exceed the total estimated costs.
4. City shall inform County of its share of costs when construction costs have been determined. County shall pay the City for its share of the cost by March 1, 2026.

5. City is responsible for acquiring all property, right-of-way, and other easements required to complete the Project, including all property, right-of-way and other easements within the jurisdiction of the County. City shall pay for all costs associated with eminent domain proceedings, if required. City shall notify Sedgwick County's Director of Public Works thirty (30) days prior to the filing of any eminent domain proceedings to determine if County wants to make final negotiated offers before the proceedings are filed. Thirty days after said notice is given, City may file for eminent domain proceedings inside the jurisdiction of Sedgwick County without further notice.
6. City will contract for construction of the Project and shall be responsible for all legal and engineering matters (except as otherwise noted in the Agreement) concerning the completion of the Project, including the required bid process and selection of a contractor for the Project.
7. City shall pay for one hundred percent (100%) of the cost of any change order related to items of work outside the Scope of Work that results in a net increase in Project costs.
8. To the extent permitted by law, City does hereby release, discharge, indemnify and hold harmless County, its agents, servants and employees from any and all liability and damages of whatsoever nature and arising from whatsoever cause, relating to or arising from errors and omissions resulting from the design of the project or from errors and omissions resulting from construction means and methods used in the construction of the project; provided, that such release shall not extend to acts or omissions of County or its agents, servants or employees in the performance of duties pursuant to this Agreement. This release and indemnity shall survive termination of this Agreement.
9. The term of this Agreement shall begin on the date first written above and continue until the date that: (1) notice of completion of the improvements has been provided by a licensed professional engineer employed by City, (2) City has made final payment to the contractor, and (3) County has paid its share to the City for the drainage improvements.





- (1) Who employs fewer than four employees during the term of such contract; or
- (2) Whose contracts with the governmental entity letting such contract cumulatively total \$5,000 or less during the fiscal year of such governmental entity.



This letter is to formally request and indeed, plead for your permission to extend the 14 day limit on parking a camper on our new property at 1932 W 69th St Valley Center. We are new residents of this area, having just purchased the above mentioned property and home, which has stood vacant for many years. As we are in the process of restoring the house, we have encountered numerous unexpected delays, including but not limited to delays in getting services from the city. This has brought us to the end of our former lease and would place us living in a house without water or sewer, which I am sure you would agree is not habitable, neither for us nor our small child. To avoid this state, we have borrowed a camper with water and sewer storage capacity for a temporary dwelling while the house is completed and services from Valley Center can be established. We do not desire nor anticipate a long wait for such to be completed.

Please be assured that this situation is temporary, and that the camper in question will be returned to its place outside of Valley Center limits as soon as possible. We are asking to be allowed to continue to park it on our property, which seems indeed like a very rural setting, for a short period until the services are installed and simple repairs completed on the house. While we do not know exactly when we will get completed services at our house, and as indeed many factors are not in our control, but yours; therefore we are asking for an extension of 6 weeks, while hoping it will be a much shorter time. This host of regulations has taken us somewhat by surprise in what does not appear to be an urban area, but we are doing all we can to comply in every respect. We request your assistance in this process by allowing us to extend the 14 day limit on parking a camper, just for a brief time.

AGENDA: A motion was made by Janzen and seconded by Conway to set the agenda. Motion passed unanimously.

APPROVAL OF DRAFT MINUTES: Janzen made a motion to approve the June 25, 2024, meeting minutes. The motion was seconded by Spranger. Motion passed unanimously.

COMMUNICATIONS: Clark informed the board that Brian Shelton has submitted his resignation from the board effective immediately.

PUBLIC HEARING BEFORE THE PLANNING AND ZONING BOARD/BOARD OF ZONING APPEALS:

1. Review of LS-2024-02, application of Bradley and Stacy Barbour, pursuant to City Code 16.09., who are petitioning for a lot split involving the splitting of property the applicants own and is currently addressed as 585 W Clay Street., Valley Center, KS 67147.

Chairperson Janzen opened the hearing for comments from the public: 7:05 PM

B. Clark gave a summary of the staff report and explained the intended use once the lot split is complete. Rodney Bruntz spoke about the structure that will be built on the property. Gene Sharp addressed the board with his concerns regarding the lot split and potential structure including noise. Bruntz addressed and answered questions and concerns. City staff recommends approval.

Chairperson Janzen closed the hearing for comments from the public: 7:10 PM

Based on the City Staff recommendations, public comments, and discussion by the Board of Zoning Appeals, Janzen made a motion to approve LS-2024-02. Motion was seconded by Wilson. The vote was unanimous.

2. Review of RZ-2024-02, application of KWH Investments, LLC, pursuant to City Code 17.11, who is petitioning for a rezoning of land that is currently zoned A-1, which is the City's designation for an agricultural district, to RR-1, which is the City's designation for a suburban residential district. The property is currently addressed at 825 W 77th and recently platted as SM Estates, Valley Center, KS 6714

Chairperson Janzen opened the hearing for comments from the public: 7:16 PM

B. Clark gave a summary of the staff report. This property has been through the platting process already. The public notices did not make the deadline for publication therefore the rezoning is now taking place. Clark met with one property owner that was curious about the process but not opposed. Bill Fox, agent for applicants, was available for questions. There were none presented.

Chairperson Janzen closed the hearing for comments from the public: 7:19 PM

Based on the City Staff recommendations, public comments, and discussion by the Planning and Zoning Board, Janzen made a motion to approve RZ-2024-02. Motion was seconded by Spranger. The vote was unanimous.

3. Review of V-2024-01, application of Max and Roy Berning, pursuant to City Code 17.10.08., who is petitioning for an accessory building to be constructed and used prior to the construction of a principal structure. Accessory building will be 1,200 square feet, located at an unaddressed location, but the lot is located just south of 5219 W 77th St. N., Valley Center, KS 67147.

Chairperson Janzen opened the hearing for comments from the public: 7:20 PM

B. Clark presented his staff report and gave details on this application. The applicant addressed the board and explained the reasoning for their application. They intend to store farm equipment, a camper, and building supplies in this accessory building with plans to start construction on their primary dwelling within 18 months of the completion of the accessory building.

Nick Thomas addressed the board in his opposition to this application. He voiced his concern about the primary dwelling not being constructed, potential for people to be living in the accessory structure or in a camper on the property as well as the property potentially being an eye sore if not completed. Discussion was had between the board, applicant, and city staff. Questions and concerns were addressed and answered.
